Hrvatska poštanska banka, p.l.c., Zagreb, Jurišićeva ulica 4 (hereinafter: HPB or the Bank) in accordance with Article 474 of the Capital Market Act and pursuant to the Notice on the Share Buyback Program for HPB own shares that began on November 8, 2023, with a duration of 2 (two) years, hereby informs the investment community that it carried out the following purchases of HPB own shares on the Zagreb Stock Exchange (ZSE) regulated market, as per the Share Buyback Program:

- 59 shares designated HPB have been purchased on November 15, 2023, at a weighted average price of EUR 183.00 per share, representing 0.002914% of the Bank's shareholder equity,
- 26 shares designated HPB have been purchased on November 16, 2023, at a weighted average price of EUR 182.00 per share, representing 0.001284% of the Bank's shareholder equity.

Information about the transactions can be found in the form attached to this notice.

Following the purchases mentioned before, the Bank is holding a total of 85 own shares, representing 0.004198% of the Bank's shareholder equity.

Shareholder equity of the Bank amounts to EUR 161,970,000.00 and is divided into 2,024,625 common shares at face value of EUR 80.00 each.
